

ORDINANCE NO: 2

**TOWNSHIP OF MICHIGAMME
MARQUETTE COUNTY, MICHIGAN
SIDEWALK ORDINANCE**

SECTION I: TITLE

This ordinance shall be known and may be cited as the Sidewalk Ordinance of
Michigamme Township.

SECTION II: PURPOSE

An Ordinance to secure the public peace, health, safety and welfare of the residents and property owners of the Township of Michigamme, Marquette County, Michigan, and the maintenance of public sidewalks within the township, by prohibiting the placement and/or maintenance of structures on or immediately adjacent to public sidewalks within the township, by requiring the removal of any previously existing structures placed or maintained on or immediately adjacent to public sidewalks within the township in violation of this ordinance, by providing penalties for the violation of this ordinance, and by repealing any ordinance or parts of ordinances in conflict herewith.

SECTION III. DEFINITION

Structure/obstruction: As used in this ordinance, the term "structure/obstruction" shall be defined as any constructed, erected, or placed material or combination of materials, including, but not limited to: signs, garbage cans or bags, storage bins or containers, and utility poles or fences. Garbage cans limited to day of garbage pick-up.

SECTION IV. PROHIBITIONS

No structure/obstruction shall be placed or maintained on any public sidewalk in the Township of Michigamme. Mailboxes are structures allowed if they are portable with a weighted base which is movable.

SECTION V. VIOLATIONS

Each day a violation of the provisions of this ordinance continues to exist shall constitute a separate offense under this ordinance.

SECTION VI. PENALTY

Failure to comply with this ordinance shall be enforced by Michigamme Township as described in Michigamme Township Civil Infractions Ordinance.

SECTION VII. SEVERABILITY

The several sections of this ordinance shall be deemed severable, and should any section, clause, paragraph, or provision thereof be declared unconstitutional or contrary to the laws of the State of Michigan and thereafter voided by any court of competent jurisdiction, the same shall not affect the validity of this ordinance as a whole or any other part thereof other than that part or section so declared to be unconstitutional or invalid.

SECTION VIII: REPEALER

All ordinances, resolutions, orders or parts thereof, in conflict with the provisions of this ordinance are, to the extent of such conflict, hereby repealed.
